Minutes of a Planning, Development Control & Highways Committee Meeting held on 20th August 2014 at 7.00pm at Tidenham War Memorial Hall

1. Receive Apologies for Absence

Information – Mr Birt and Mrs Kirkpatrick attended a SIP council meeting at The Rising Sun (P1355/13/FUL)

5. Public Consultation

A local resident presented views on the draft Allocation Plan and its impact on the recently withdrawn planning application P1010/14/FUL (Orchard Lee, Bishton Lane). The owner made an application in 2013 to have the settlement boundary changed to allow a development on his property. The application was rejected by the District Council at that time. However, the current draft Allocation Plan proposes making the boundary change in question and others in the Woodcroft area. The speaker considers this to be one step nearer to granting planning if a fresh application is submitted. The speaker also disapproved of the way the original boundary change application for Orchard Lee was processed without reference to the Parish Council and that the boundary changes proposed in the Draft Allocation plan had also been introduced by FODC without consulting the Parish Council

The Committee discussed a letter regarding boundary changes proposed in the draft Allocation Plan. The letter is from the public speaker in item 5

The Chair has spoken to The Highways Department and reported that:

- The ground survey for the Allocation Plan picked up several anomalies where the settlement boundary passed through gardens or buildings. These were rationalized in the draft plan
- The boundary changes do not constitute the proposal of a development site
- The land in question (withdrawn planning application P1010/14/FUL) is currently classed as unsuitable for development

The public speaker replied that the applicant sought pre-planning advice from *FODDC* which was positive and did not mention the site being unsuitable for development.

Speaker was advised to write to the District Council Planning Committee and Full Council to complain and ask supplementary questions.

- Mrs Bollen reported that the garage opposite Sedbury Post Office is for sale as a development site.
- Miss Gregory reported that the overgrown hedge in Loop road has still not been cut back despite a letter from the Highways Department requesting the owner do so after the end of July. The property is now on the market. It was agreed that the Administrator to write to the Highways Department to report the situation
- Mr Birch reported that two areas of grassed land in Bigstone Grove are not being cut. Residents are doing it themselves
- Mr Bowshall provided evidence to show that a house build which was granted planning permission on a revised plan is being built to the original disallowed plan. It was agreed that the administrator will inform the Enforcement Officer and copy to Councillor Kirkpatrick
- Mr Birt reported that the sewerage leakage in Coleford Road has stopped after a temporary repair
- Mr Birt reported a manhole cover missing in Bishton Lane. It was agreed that the Administrator to report the missing cover to the Highways Department
