**Minutes of a Planning, Development Control & Highways Committee Meeting held on 23<sup>rd</sup> July 2014 at 7.00pm at Tidenham War Memorial Hall**

**5. Public Consultation**

Two local residents spoke about P1010/14/FUL (Orchard Lee) raising issues with the plans not being clear, the development falling outside the Settlement Boundary, an apparent lack of drainage, restriction of the view over the playing fields, road safety due to extra vehicles, the effect on biodiversity and the lack of renewable materials in the build.

Three local residents spoke about P1355/13/FUL (The Rising Sun). Their original understanding is that the pub was to be sold as a going concern and not for development. They said the proposed business plan does not clearly demonstrate its non-viability as a public house and that, along with it being a loss as a community facility, is a breach of the Core Strategy. They are confident of raising the money to obtain the property and run it as a public house and shop, plus make it a community hub with an assortment of activities.

**Objection**

- The development is outside the Settlement Boundary contravening the Core Strategy
- It is a 'back garden' development contravening District Council policy
- No draining is shown in the plans and it's an area prone to waterlogging
- The extra traffic and poor visibility in the narrow lanes is a safety issue

- **P0768/14/FUL Stroath House, Stroath.**

Proposed garden room and terrace at rear of kitchen, screen wall. Retention of buttery staircase

**No objection**

- **P0769/14/LBC Stroath House, Stroath.**

Listed building consent for above

**No objection**

- **P1355/13/FUL The Rising Sun, Woodcroft.**

Change of use of public house to x2 residential dwellings

**Objection**

- The 2m high outside wall presents a highway safety issue in that it limits visibility to traffic emerging from Woodcroft Lane and Stoulgrove Lane
- The 2m high outside wall reduces light to neighbouring properties (The Old Bakery and Hilltop Cottage) resulting in a loss of amenity
- The application has been 'called in' due to the high level of public interest
- The Business Appraisal is misleading and not completely factual
- The plan is contrary to CSP8 in that the developer has not demonstrated adequately the non-viability of the original business
- The plan shows a number of East facing windows which will overlook Hilltop Cottage

- **P1115/14/TPO 2 Bigstone Meadow.**

Maximum crown reduction of 15% to x3 yew trees, removal of x2 lower branches from oak and removal of x2 lower branches of beach tree
