These beacons are in line with the manufacturers specifications and under TSRGD guidelines which would appear to be black in this instance. Google maps 2017 shows these as black, which would indicate that they are simply dirty. I will raise a job for our contractor to attend and inspect and clean as necessary.
- b. **To note** No flag on bus stop opposite Wyedean School, Beachley Rd from Glos CC Highways: Enquiry passed to Integrated Transport.
- c. **To note** 2 overgrown patches of grass that have not been cut and are obscuring views of traffic -1) on the corner of Grahamstown Rd and Beachley Rd and 2) at the top of Tylers Way From Glos CC Highways: Scheduled for cutting 27 June.
- **d. To note** broken poles on centre island leaving the Sedbury/Beachley Rd roundabout from Glos CC Highways: Passed to Local Highways representative.
- **e. To note** Woodcroft and Tutshill signs incorrect new sign for Woodcroft has been replaced reported to Glos CC Highways.
